  - 6.1 Superintendent Report Mr. Finster reported that the State budget should be available the end of April or beginning of May. Governor Hochul has removed the Save Harmless Safety Net. There are two major factors in the Foundation Aid formula, enrollment and land wealth. NYS has said they will give more Foundation Aid. However, the Save Harmless Safety Net would not take in account for decreased enrollment. Our school district has not been fully funded for Foundation Aid for many years; however, 2022/2023 we were fully funded. Governor Hochul has proposed to take away the Save Harmless Safety Net, which would have HCS with a decrease of approximately \$60,000. Governor Hochul is getting pushback from Albany since this would hurt small rural school districts. Mrs. Frost has done a good job counting for this, and Mr. Finster feels fairly confident there will not be cuts for the 2024 2025 school year. He will be joining other Superintendents along with our Legislators in Albany mid-March regarding the State's budget.

  - 6215 Probation and Tenure Revised in light of an amendments to law which, among other things, exempt districts from having to complete an annual professional performance review (APPR) for any classroom teacher or building principal for the 2020-2021 and 2021-2022 school years.
  - 7350 Corporal Punishment/Emergency Interventions Revised in light of an amendment to <u>Education Law Section 4402</u> which requires same-day notification of a parent r person in parental relation of a student with a disability when a physical or mechanical restraint is applied on the student.
  - 7522 Concussion Management Revised in light of the release of updated <u>Guidelines for Concussion Management in Schools</u> (July 2022) from the New York State Education Department.
